# **PARVOVIRUS** ACTINMUN MANUAL, SPECIFICATIONS



### TECHNICAL DATA SHEET FOR ACTINMUN SERUM AGAINST PAR-VOVIRUS AND DISTEMPER (POLYCLONAL HYPERIMMUNE SERUM):

### **1. NAME OF THE MEDICATION**

ACTINMUN against Parvovirus and Distemper

### **2. TECHNICAL NAME**

Polyclonal Hyperimmune Serum against Parvovirus and Distemper (\*PHS).

### **3. COMPOSITION/ACTIVE INGREDIENT**

Canine blood serum with antibodies against Parvovirus and Distemper, lyophilized.

As a preservative, it contains 1 ml of enrofloxacin per liter of Polyclonal Hyperimmune Serum (\*PHS).

### 4. PHARMACEUTICAL FORM AND PRESENTATIONS

PHS\* is lyophilized and comes in 20 ml and 40 ml injectable water dilutable presentations (injectable water is not included).

### 5. Therapeutic Indications for ACTINMUN Serum Against Parvovirus and Distemper (Polyclonal Hyperimmune Serum):

**a)** For the treatment of dogs and other exotic carnivores affected by Parvovirus (PVC-2 of any antigenic subtype) at any stage of the disease, regardless of age.

**b)** For the treatment of dogs suffering from both Distemper and Parvovirus simultaneously.

**c)** As an adjuvant in the treatment of gastroenteritis that does not respond to conventional medical treatments and in cases where the presence of Parvovirus and/or Distemper is suspected, even when diagnostic tests have returned negative results (False negatives).

### 6. HANDLING OF ACTINMUN SERUM:

During transport, ACTINMUN Serums do not require refrigeration due to being lyophilized and can be kept in a dark and cool place for short periods of time. However, if frozen at a temperature between MINUS 11 and MINUS 30 degrees Celsius, their shelf life can be extended, even beyond the expiration date.

Once the ACTINMUN serum arrives and is fully diluted with INJECTABLE WATER (exclusively), it can be administered by the veterinarian according to the instructions in this manual (the reconstituted serum must be refrigerated at a temperature of 2 to 5 degrees Celsius or frozen at the lowest possible temperature).

### 7. POSOLOGY (DOSAGE):

The dose of ACTINMUN against Parvovirus and Distemper is 4 to 7 ml per kilogram of body weight, aiming for the highest dose.

### 8. WARNINGS TO CONSIDER WHEN ADMINISTE-RING ACTINMUN SERUM (PHS):

Since ACTINMUN is a biological product containing canine blood serum, it may, in rare cases, trigger an allergic or hypersensitivity reaction in predisposed dogs. Therefore, it is advisable to administer ACTINMUN serum following the Besredka method: inject 0.1 ml subcutaneously (SC) into the inner thigh and wait 15 minutes; in the absence of a local or general reaction, inject 0.25 ml SC and wait another 15 minutes; in the absence of a local reaction, inject an antihistamine (Diphenhydramine) at therapeutic doses, and 10 minutes after applying the antihistamine, inject 30% of the total dose of ACTINMUN serum subcutaneously into the inner thigh or abdomen, monitor for adverse reactions, and inject the remainder intramuscularly.

Part of the ACTINMUN serum can be administered intravenously slowly (using the syringe, not through a drip) over a period of one to two minutes after the intramuscular injection, observing for any adverse reactions and monitoring vital signs for one hour to ensure there are no signs of allergy or hypersensitivity. If they appear, provide the necessary medical attention. The purpose of this is to try to prevent or reduce the severity of any potential allergic or hypersensitivity reaction, although this is very rare.

It is important to be prepared in case of allergy or hypersensitivity, keeping adrenaline, antihistamine (diphenhydramine), and dexamethasone (corticosteroids) on hand. In general, the PHS is a SINGLE DOSE, but AC-TINMUN serum may be administered again at the discretion of the veterinarian until a total dose of 10 ml of ACTINMUN per kilogram of body weight is reached.

### 9. USE OF BACTERIOSTATIC ANTIBIOTICS WHEN ADMINISTERING ACTINMUN SERUM

During treatment with ACTINMUN, we recommend using antibiotics with a BACTERIOSTATIC effect and preferably avoiding antibiotics with bactericidal activity. This helps reduce the likelihood of hypersensitivity reactions due to the release of endotoxins from gram-negative bacteria that pass from the intestine into the bloodstream and are destroyed by the effect of bactericidal antibiotics, releasing their endotoxins.

If you are already using bactericidal antibiotics, do not delay; proceed with the application of AC-TINMUN serum as soon as possible, following the instructions mentioned earlier.

### **10. SYMPTOMATIC TREATMENT AND CONTRAIN-DICATIONS**

It is very important to continue with appropriate symptomatic treatment implemented by your veterinarian. ACTINMUN serums have no contraindications.

### **11. IMMUNE RESPONSE AFTER ADMINISTRA-TION OF ACTINMUN SERUM (PHS) IN PUPPIES SICK WITH PARVOVIRUS AND DISTEMPER**

Dogs get sick from Parvovirus or Distemper because they lost or did not produce antibodies against these viruses before becoming infected. By injecting ACTINMUN, we immediately transfer the antibodies they need, which in immunology is called the immediate transfer of passive immunity (temporary borrowing of antibodies).

The primary mission of the immunoglobulins (antibodies) in ACTINMUN (PHS) is to neutralize the Distemper and Parvovirus viruses, facilitating their elimination through cellular immunity. These polyclonal antibodies in the ACTINMUN serum reduce the infectivity of the virus by inhibiting various stages of the viral replication cycle. They do this by binding to different epitopes of the virus, achieving opsonization (a key advantage of ACTINMUN as a polyclonal hyperimmune serum), thereby preventing the viruses from attaching to target cell membranes and facilitating phagocytosis (that is, the ingestion of the antigen-antibody complex by leukocytes), ultimately leading to the end of the infection and the start of recovery.

Parvovirus causes damage to lymphoid tissue and bone marrow, leading to severe leukopenia (a drastic decrease in white blood cells). In other words, it blocks the production of leukocytes (white blood cells) in the bone marrow and other lymphoid tissues, depleting them from the bloodstream and causing immunosuppression. In intestinal cells, the viruses primarily multiply in the crypts of young animals' intestines (Parvovirus invades and destroys the body's rapidly dividing cells). Therefore, it is very important to administer ACTINMUN Hyperimmune Serum to the puppy at any stage of the disease, preferably as soon as possible, while they still have sufficient leukocytes in their bloodstream. A favorable prognosis in Parvovirus infection is related to the synergy between antibodies and white blood cells.

The antibodies are specific to Parvovirus and Distemper viruses.


The ANTIBODIES will remain in the treated animal's body for a maximum of 25 days, after which it can receive the remaining vaccines and complete its full vaccination schedule. Parvovirus infection only occurs once in a dog's lifetime.

### **Important Note:**

In Parvovirus infections, puppies between 6 weeks and 6 months of age are at higher risk, although dogs up to one year old may also contract it. Dogs older than one year rarely suffer from Parvovirus, but cases have been reported.

Breeds like Rottweiler, Doberman Pinscher, Pit Bull, Labrador Retriever, Staffordshire Terrier, German Shepherd, and Alaskan Malamute have a higher genetic predisposition to infection. In general, dark-coated dogs are more predisposed (Sherding 1994; Hoskins 2000).
